



Shell Card Registered Building Network (RBN) offer terms and conditions (“Offer”)

1. Information on how to participate in this Offer forms part of these Terms and Conditions. Participation in this Offer is deemed acceptance of these Terms and Conditions. All dates and times stipulated in these Terms and Conditions are AEST or AEDT.
2. Applications for this Offer must be received by July 31, 2022 (“**Closing Date**”). We reserve the right to withdraw or vary this Offer prior to this date (and prior to Applications for the Offer being accepted).
3. Participation in the Offer is only open to Eligible Businesses and in relation to Eligible Purchases.
4. An eligible business is an Australian business that holds a valid ACN/ABN that submits a Shell Card account application before the Closing Date (“**Eligible Business**”).
5. To participate in the Offer, an Eligible Business must quote the promotional code “DIRECTFSC” at the time of applying for the Shell Card account.
6. Only one (1) Shell Card account is permitted per Eligible Business for the purposes of participation in this Offer. Each Eligible Business may have multiple representatives who each receive a Shell Card on behalf of the Eligible Business.
7. The Offer entitles Eligible Businesses to a discount of six (6) cents per litre off the pump price of all fuels excluding LPG and AdBlue at all Shell Branded and affiliate retail sites for six (6) months and four (4) cents thereafter. All discounts are expressed on a GST inclusive basis.
8. No monthly card fees or transaction fees for six (6) months. After this time the monthly card fee will be \$2.50 per Card.
9. The applicable discounts will be applied for a period of six (6) months after initial card production plus five (5) days “Offer Period”.
10. No further discounts will apply for the duration of this Offer.



11. We may in our discretion apply a post Offer discount, based on factors which may include your volumes purchased over the period of the Offer. The more volume purchased the larger your post Offer discount could be.
12. Available payment terms are Y07W (Weekly invoicing, with payment due the 7th day following the invoice date), Y14F (Twice monthly invoicing, with payment due the 14th day following the invoice date) and Y07M (Monthly invoicing, with payment due on the 7th day of the following month) only. The payment terms offered to each individual applicant will be at the discretion of us. Payment must be via direct debit from either a bank account or credit card. Mastercard and Visa accepted. Surcharge of 0.8%+ gst.
13. This Offer applies only to new Shell Card accounts.
14. All Shell Card account applications are subject to normal credit approval and other account opening criteria.
