

Shell Card “FINDER24” offer terms and conditions

1. Information on how to participate in this Offer forms part of these Terms and Conditions. Participation in this Offer is deemed acceptance of these Terms and Conditions. All dates and times stipulated in these Terms and Conditions are AEST or AEDT. The Offer is conducted by Viva Energy Australia Pty Ltd (ABN 46 004 610 459), of Level 16, 720 Bourke Street, Docklands, VIC 3008 (“Viva Energy”, “we”, “us”, “our”).
2. Applications for this Offer must be received by 31 JANUARY 2028 (“**Closing Date**”). We reserve the right to withdraw or vary this Offer prior to this date (and prior to Applications for the Offer being accepted).
